

## Privacy notice for selection of suppliers and consultants

The Company of the Bosch Group, whose contact details are available on the footer of the e-mail to which this notice is attached, and in preparation to a future purchase, to which this information notice relates to, in its capacity as Data Controller (hereinafter the “Company”), hereby informs all natural persons suppliers and consultants, participating in the selection for future purchasing activities, pursuant to articles 13 and 14 of EU Regulation No. 679/2016, that their personal data will be processed for the purposes of carrying out preliminary checks, for the selection of the supplier and consultant to be entrusted with the provision of the service and for the correct performance of the necessary pre contractual measures.

Furthermore, the Company may receive – in full compliance with the pertinence and minimization principles, with respect to the above described purposes – information relating to suppliers and consultants’ economical and financial situation, from external suppliers who professionally provide services of exchange of commercial information pursuant to art. 134 of the T.U.L.P.S. and D.M. 269/2010, and that will process personal data as autonomous data controllers. Such processing is carried out on the basis of the Company’s legitimate interest.

Pursuant to the Company’s internal procedures such personal data – managed by employees of the Company – will be stored in paper and electronic databases and processed in modalities which are necessary to the purposes described. The personal data will be stored for the time necessary to the possible selection of the supplier or consultant for the provision of the service that the Company intends to purchase, and for the additional time required by the law. In the event the supplier takes part in another purchase activity, the Company may take into consideration the personal data previously provided the supplier or otherwise collected by the Company.

In case the supplier is selected, and the purchase takes place, its personal data will be processed for the execution of the contract: an additional information notice will be provided to the supplier in such case.

The Company may also communicate personal data to:

- other professionals or consultants providing services connected to the purposes described above;
- other companies of the Bosch Group, on the basis of the Company’s legitimate interest to transmit personal data within its group of undertakings for internal administrative purposes, pursuant to recital 48 of EU Regulation No. 679/2016.
